TREASURER'S REPORT AND BILLS FOR APPROVAL: Upon motion of Chairman Lutz, seconded by Supervisor Brown, the March 2020 Treasurer's Report was approved with a balance in all accounts, before receipts and bills, was \$699,976.73. SOLICITOR'S REPORT: No Solicitor report.

TOWNSHIP REPORTS: Due to the Governor's stay at home order the road crew was laid off on March 23, 2020. The Board discussed their return to work. After some discussion regarding amount of work available it was decided that they would return Monday April 27, 2020. All Board members agreed.

COUNTY ZONING: A Planning and Zoning report was reviewed by the Board. A copy of this report will be kept on file at the **Municipal Office**.

SEWAGE ENFORCEMENT OFFICER'S REPORT: No SEO report for March 2020.

BUILDING/DRIVEWAY REPORTS: No building permits were issued for the April 20, 2020 meeting.

OLD BUSINESS: No old business to discuss.

<u>NEW BUSINESS:</u> Upon motion made by Vice-Chairman Gainer approving **Resolution 2020-7** Declaration of Disaster, seconded by Chairman Lutz. This motion unanimously carried.

Upon motion made by Supervisor Brown approving the hiring of Rimkus Building Consultant to investigate the water issue with the township building windows, seconded by Vice-Chairman Gainer with the condition they will not do anything to make the issue worse. This motion unanimously carried.

Supervisor Brown asked if the Park should be opened. After some discussion it was decided to put up a sign stating the park is closed until the stay at home order is lifted.

Chairman Lutz asked if there was going to be any discussion on the Kutz Bridge Inspection. Koch stated it was just received and was a copy for the Board to review until next meeting. Vice-Chairman Gainer stated he looked at the inspection report and stated everything looks in order to move forward.

ADJOURNMENT: There being no further business to come before the Board of Supervisors of Washington Township, upon motion of Chairman Lutz, seconded by Supervisor Brown, the meeting adjourned at 7:21 p.m. This motion unanimously carried.
