WASHINGTON TOWNSHIP BOARD OF SUPERVISORS ANNUAL RE-ORGANIZATION MEETING - 1/6/2020

The annual reorganization meeting of the Washington Township Board of Supervisors was held Monday, January 6, 2020. Those in attendance were: Chairman Leon Lutz, Vice-Chairman Wendell Gainer, Supervisor Lynn Brown, Dawn Koch, Sal Varacalli, Barry Newswanger and Gary Brown.

Chairman Leon Lutz called the meeting to order starting with the pledge of allegiance. Chairman Lutz reminded the residents of the policies in force regarding meeting conduct and public comment procedures.

PUBLIC COMMENT: No public comment.

APPOINTMENT OF CHAIR AND VICE CHAIR: Upon motion of Supervisor Leon Lutz, seconded by Supervisor Brown, Supervisor Wendell Gainer was appointed as temporary Chairman of the Board. Vote: Two yes, Wendell Gainer abstained. Motion carried.

Supervisor Wendell Gainer nominated Supervisor Leon Lutz to serve as Chairman of the Board for 2020. Supervisor Lutz accepted the nomination. The motion was seconded by Supervisor Brown. Vote: Two yes, Leon Lutz abstained. Motion carried.

Chairman Lutz nominated Supervisor Gainer to serve as Vice-Chairman of the Board for 2020. Supervisor Gainer accepted the nomination. The motion was seconded by Supervisor Brown. Vote: Two yes, Wendell Gainer abstained. Motion carried.

2020 WAGES: Vice-Chairman Gainer stated that Lynn Brown's rate will be set by the Auditors at their reorganizational meeting Tuesday, January 7, 2020.

Upon motion made by Vice-Chairman Gainer approving **Resolution 2020-Four** increase Township Managers salary to \$62,640.00 per year, seconded by Supervisor Brown. This motion unanimously carried.

Upon motion made by Vice-Chairman Gainer approving a 5% salary increase for Chris Light to \$17.32, seconded by Chairman Lutz. This motion unanimously carried.

Upon motion made by Vice-Chairman Gainer approving a 1% salary increase for Gary Wolfe to \$21.01, seconded by Chairman Lutz. Included in the motion is the approval of an additional 2% increase based on a six-month evaluation for a total 2020 rate of \$21.43. This motion unanimously carried.

Upon motion made by Vice-Chairman Gainer approving part-time rate to be determined on a case by case basis not to exceed \$18.36 per hour with a starting rate of \$14.00 per hour, seconded by Chairman Lutz. This motion unanimously carried.

Upon motion made by Vice-Chairman Gainer approving the EMC, Carl Stump's wage to \$19.75 per hour, seconded by Supervisor Brown. This motion unanimously carried.

<u>2020 FEES:</u> Upon motion of Vice-Chairman Gainer, seconded by Supervisor Brown, **Resolution 2020-Five Driveway Permit Fee Schedule** was approved keeping the fee at \$250.00 per permit. This motion unanimously carried.

Upon motion of Vice-Chairman Gainer, seconded by Chairman Lutz, the Sewage Permit fee schedule submitted by JB Environmental Services LLC was accepted. This motion unanimously carried.

Upon motion of made by Chairman Lutz approving to keep the Agriculture Structure Permit Fees the same as 2019, seconded by Vice-Chairman Gainer. This motion unanimously carried.

OLD BUSINESS: No old business

NEW BUSINESS: Koch presented the Board with a proposal received from Little Bugger Enterprise proposing a 2% increase of 2019 rates to perform lawn care maintenance in 2020. Upon motion made by Vice-Chairman Grainer approving the proposal submitted by Little Bugger Enterprises to provide lawn care to the township at the municipal building and ballpark at a 2% increase of the 2019 rates, seconded by Supervisor Brown. This motion unanimously carried.

Koch presented the Board with a proposal received from Sparkle Cleaning Service to perform monthly deep cleaning of the township office building. Vice-Chairman Gainer asked Koch what the issues were that lead to the dismissal of services. Koch stated dusting, floors not being vacuumed, bathrooms not being cleaned properly. Vice-Chairman Gainer asked Koch if she was willing to continue performing the service. Koch replied yes. Upon motion made by Vice-Chairman Gainer to keep the cleaning of the office building in house, seconded by Chairman Lutz. This motion unanimously carried.

ADJOURNMENT: There being no further business to come before the Board of Supervisors of Washington Township, upon motion of Supervisor Brown, seconded by Chairman Lutz, carried by all, the meeting adjourned at 7:23 p.m.
