WASHINGTON TOWNSHIP BOARD OF SUPERVISORS ANNUAL RE-ORGANIZATION MEETING - 1/2/2024

The annual reorganization meeting of the Washington Township Board of Supervisors was held on Tuesday, January 2, 2024. Those in attendance were John Krause, Eric Wolfe, Lynn Brown, Holly Reinford, and Barry Newswanger.

John Krause called the meeting to order starting with the pledge of allegiance. John Krause mentioned the notices regarding disrupting a meeting and the Sunshine Act.

<u>PUBLIC COMMENT:</u> Resident and Auditor Barry Newswanger inquired about the winter maintenance on state routes. Supervisor Brown stated the first winter storm he and his crew were headed to Erie to look at a truck and turned around to come back and clear the roads. Brown stated he called EMC Nick Miller to help until they returned. Newswanger asked that he be called for any road closures that would affect bus routes. He also inquired about a resolution for an outside auditor. Secretary/Treasurer Reinford stated we will appoint an outside CPA in the February meeting.
